Meeting was called to order by Sonny Garza.

Motion to approve the minutes from October 8, 2007, was made by Chris and seconded by Mark. All approved.

COMMITTEE REPORTS

Neighborhood Bliss

Neighborhood Bliss will hold a clean-up day on Sunday, May 25. Meet at 920 Spruce (Beaulieu) at 12 noon. They will be planting some annuals and perennials at the North entrance. They also will be cleaning up the trees/plants around Bliss Park and the North entrance.

Landscape

Alan Horticultural Enterprises handles the landscaping for our subdivision. They are out here every Friday mowing.

Sonny will meet with them on May 14 to discuss the following areas:

- Waterfall pump - need better plant coverage around pump
- South entrance – burning bushes at the South entrance are growing at different rates. Need to move them to another location and plant something more durable in those locations.
- South entrance sign – light is shining into resident’s windows at 901 Spruce. We will see what type of hedges they recommend to defuse the light.

Mulch was added in some common areas which were not covered last year.

Maintenance

Waterfall is on.

Algae treatment for ponds is done at least once a month, more if needed. Scientific Aquatic will be coming out soon for the first treatment this year.

Sprinkler System is not ready yet. Call The Underground will be coming out soon to put the intake hose into the ponds and prepare the sprinklers. The system is

set on timers and last year we had rain sensors installed so that the sprinklers to not run when it is raining.

Fishing in the ponds – We have had complaints that non-residents are parking their vehicles around the neighborhood to fish in our ponds. Sonny spoke to Sugar Grove Police Sgt. Gilkey about this matter. Sgt. Gilkey said that they were called out one night about persons fishing in our ponds and these persons were told to leave. However, since there is no signage out, there is not much the police can do. After discussion with the residents that attending this meeting, it was decided that we needed signage stating “Private property-Residents Only” by the ponds and parks. Sonny will discuss the proper verbiage with our attorney.

Waterfall- We have had problems this year already with kids and adults climbing the waterfall. We will see if we can put signage up there also.

Flags- New flags have been put up. New Bliss Woods flags have been ordered. We had a problem with the light but John Elleby (LOBW resident who handles electrical issues) fixed it.

Sign light at South entrance, south side – We have problems with getting electricity to this location. There are legal issues with the easement. Our attorney is working with the Village attorney to correct the easement with Lot 1.

Muskrat control – We are in year 2 for controlling them. Muskrats are causing big erosion problems around the ponds, especially at 901 Spruce. Muskrats have tunneled far into their yard so much that they have to be careful where they walk. The tunnels cave in when walked on. Traps were changed to live traps on all 3 ponds and they are in the water so that kids can not get trapped in them. Trapper brings the muskrats far away from here so that they do not come back. Big issue is that some people do not want them and others do. However, someone has been purposefully tripping the traps with rocks and tennis balls so that muskrats can not get caught.

NEW BUSINESS

Contracts

Nemanich – signed a 3 year contract to renew their management services

Call The Underground – signed a 1 year contract for sprinkler system maintenance

Scientific Aquatics – signed a 1 year contract for pond algae treatments

Alan Horticultural – we are in 2nd year of a 3 year contract

Website

Up and running at www.Blisswoods.org . Residents can obtain architectural review forms from the website. Some amendments to the Covenants need to be added still.

Speed limits

We have not been able to get the speed limits changed to 25 mph. We will work with the HOA alliance to see multiple neighborhoods can approach the Village to get a better response. There have been complaints about speeders at Willow/Elm coming from Hannaford. Police have set up a speed trailer in Hannaford and are patrolling the area.
